

# Delivery / Collection of Aircraft Engines or Parts to AERO NORWAY AS

The below information applies to Transport arranged by Aero Norway customers.

## NOTIFICATION

- Aero Norway engineshipping@aeronorway.no
  - EMAIL Subject should read: *Customer Name ESN XXXXXX Subject.* 
    - The ESN number is the minimum of information in all communication and should be included in all related documents.
  - For **delivery**, please provide estimated time of delivery (ETA) along with copies of documents, truck ID and driver's ID as soon as possible.
  - For **collect**: Provide the engine's destination address, contact details for your appointed agent, if different, the collection agents contact details, **and truck ID**.

### **Opening Hours**

- Offloading / Loading Opening hours 07:30 14:00 Monday to Friday. Weekends and times outside normal opening hours need to be agreed in advance (Written).
- Upon arrival trailers must stop for registration with the entrance sign, approx. 60 meter after the gate entrance.

#### DELIVERY

• Shipping Invoice issued to Aero Norway AS, Flyplassvegen 220, 4055 Sola, should include engine and stand on separate lines with serial number, customs value, weight & dimension & HS code.

- CFM56-3, -5 and -7 engines and its parts is for civil aircrafts only (commercial airline for transport passengers) and are classified under US regulation.
  - o ECCN CODE 9A991
- ROAD Transport documents. (T1)
  - Customs clearance: Shipping documents and arrival notice to be sent to our agent Håkull AS <u>customs@haakull.no</u> for clearance and closure.
  - o T1-document to be issued to Aero Norway, customs office of destination NCTS:NO345002,
    - o Contact engineshipping@aeronorway.no \_Aero Norway EORI/ VAT# 898433072
  - T1 document must be stamped by customs before closure, and sealed containers must be released by customs (see page 3 for the address)
  - $\circ~$  Upon completion the engine will be off loaded and registered in our bonded warehouse D
- AIRFREIGHT to SVG (If OSL be aware that there is a min of 9 hours' drive to AN)
  - AWB to be issued to Aero Norway, Flyplassvegen 220, 4355 Sola and marked with ESN number and "Please notify Haakull Air& Sea email: <u>airsea@haakull.no</u> for customs clearance."



## <u>COLLECT</u>

- Customer to provide.
  - o Final delivery address necessary for the shipping Invoice,
  - Appointed Transport Agent contact details, preferably e-mail, name and telephone number.
- Aero Norway will provide.
  - Shipping Invoice for customer approval
    - including address supplied by customer, engine and engine-stand on separate lines with serial number, incoming customs value, weight & dimension, HS code.
  - Export declaration (EX1)
  - o Purge Statement or Shippers Declaration
- Appointed Transport AGENT to provide.
  - Is responsible for all other documents required for transport and customs clearance to the redelivery destination.
  - Norway is not a member of EU and for driving / delivery within EU a T1 document needs to be issued /opened by the appointed agent.
  - CFM56 Engines Transportation Guide 2023 rev00 to be found below.

## **Delivery of customer owned PARTS**

• Notification as mentioned on page 1.

- Shipping invoice / document AWB, CMR should always indicate the engine serial number or the customer for whom the parts are intended.
- Preferable shipping methods is by DHL express.
- For airfreight, AWB to be issued to Aero Norway, Flyplassvegen 220, 4355 Sola and marked with ESN number and
